NOTICE 1205 OF 2005

DEPARTMENT OF ENVIRONMENTAL AFFAIRS AND TOURISM

FURTHER INSTRUCTIONS FOR THE COLLECTION OF APPLICATION FORMS AND PAYMENT OF APPLICATION FEES FOR FISHING RIGHTS TO UNDERTAKE COMMERCIAL FISHING FOR HAKE HANDLINE AND WEST COAST ROCK LOBSTER (NEARSHORE), IN TERMS OF SECTION 18 OF THE MARINE LIVING RESOURCES ACT 18 OF 1998

These instructions are issued by the delegated authorities responsible for allocating commercial rights in the section listed above. The instructions are in addition to those issued under Government Notice 1147 of 22 July 2005 and must be read together with those instructions.

Persons wishing to apply for rights to undertake commercial fishing in the fisheries listed above must take the following to any one of the distribution centres listed below (see Table 1 below) which will only be open between 08h30 and 16h30 from Monday 25 July 2005 to Friday 29 July 2005:

1. a cheque or a postal order made out to the “**Rights Verification Unit**” in the amount of the applicable application fee (see Table 2 below). Applicants will not be given an application form unless they submit the required application fee in the form of a cheque or postal order. **Applicants may not pay in cash or in any other form other than by cheque or postal order;**
2. a letter on the applicant close corporation’s letterhead authorising the individual collecting the application form to do so on behalf of the applicant (**this applies only to applicants that are close corporations in the hake handline sector**);
3. the identity document of the individual collecting the form and a copy of the first page of this person’s identity document; and
4. if the application form is collected by someone else on behalf of a natural person applicant then a letter authorizing the individual collecting the application form to do so on behalf of the applicant.

Applicants will be required to complete a registration form at the distribution centre and must have the following details ready for this purpose:

1. applicant’s residential address or address of principal place of business, applicant’s postal address, applicant’s telephone and fax numbers and e-mail address; and
2. if the applicant is a close corporation in the hake handline sector, then also the authorised contact person’s name, identity number, position held at applicant (or relationship to the applicant), cellular, landline and fax numbers and e-mail address.

Applicants must submit the completed application forms and annexures on either 18 August 2005 (between 08h00-19h00) or on 19 August 2005 (between 08h00-17h00) at one of the places and venues specified in the application forms.

IMPORTANT: YOU MUST READ THIS:**Should you:**

- Fail to pay your application fee and collect your application form before 16h30 on 29 July 2005, or pay less than the required application fee, or pay your application fee in any manner other than that stated above, your application will be refused;
- Submit your application at a place other than one of the places and venues specified in the application form, your application form will be refused; or
- Submit your application on a date other than 18 August 2005 (between 08h00-19h00) or 19 August 2005 (between 08h00-17h00), your application will be refused.
